Wear this, wear that, be a woman, don't be too fat, don't be too thin, man like women who look this way, you're wearing too much, you need to learn how to sing, be a lady that is what men want. Women are always having to fall into the standards of society; they are never seen as intelligent, as brave,

However, Darcy is attracted to Elizabeth because he is infatuated with her strong views and perspective on things. She shows how a woman can have intelligence and a mind of their own. Nonetheless, Darcy defeated his pride and proposed to Elizabeth making it clear that all along his pride restricted his attraction for her, "in vain, I have struggled. It will not do. My feelings will not be repressed. Her family wasn't wealthy, they were considered lower class. But Elizabeth's dad, Mr. Bennet wanted all his daughters to find someone wealthy and worthy of their love so they could be set in society.
